## Appliance Rebate - Applicant's Check List INCOMPLETE FORMS WILL BE RETURNED

- I am a Muscatine Power and Water (MP&W) residential electric customer and the account holder listed on this form.
- I have attached my original sales receipt(s) to this form. All receipts are for items purchased in my name.
- I have attached my energy guide(s) for the following appliances: dishwashers, clothes washers, room air conditioners, refrigerators, and central air conditioners.

**NOTE: Energy guides for those listed above MUST be included to receive rebate!**

- (Refrigerator rebates) I have turned my old refrigerator in to a participating dealer or the City of Muscatine and this form has been signed to verify its disposal. (See reverse side for details.)
- I have completed all necessary information on the reverse side of this form. I have attached all required materials to this rebate form. (Energy guides, receipts, etc.)
- I have read the terms and conditions below, and have signed the customer certification on the reverse side.

**Deadlines:** Items must be purchased between January 1, 2010, and December 31, 2010. Applications must be filed by March 31, 2011. MP&W reserves the right to change any portion of this program or to end this program at any time without notice.

**Rebate Amounts and Payments:** Rebates will not exceed purchase price. Rebate applications will be processed as they are received. Please allow 4 to 6 weeks for payment.

**Qualifying Purchases/Eligibility:** New electric refrigerators, dishwashers, clothes washers, dryers, ranges, room-air and central-air conditioners, ground-source heat pumps, and water heaters are eligible for this program. The new appliances must meet all specified energy efficiency requirements. Compact fluorescent bulbs eligible for this program include both integral ballast (one-piece unit) and adaptor ballast (two-piece unit) models. MP&W does not endorse any particular manufacturer of appliances. Only MP&W residential electric customers are eligible for these rebates.

**Verification: Original sales receipt(s) indicating make, model, purchase date, purchase location, quantity, and price must accompany rebate application. Energy guides for those items listed above (in the checklist section) MUST be included to receive rebate! Incomplete applications will be returned.**
