**Eligibility:** This program offers rebates for purchasing energy-efficient compact fluorescent bulbs, room air conditioners, central air conditioners, water heaters, and ground-source heat pumps as specified. Commercial customers in the Muscatine Power and Water (MP&W) service area are eligible for these rebates. Items must be purchased between January 1, 2011, and December 31, 2011. Applications must be filed by March 31, 2012. MP&W reserves the right to change any portion of this program or to end this program at any time without notice.

**Qualifying Purchases:** Compact fluorescent bulbs must be ENERGY STAR-rated. MP&W does not endorse any particular manufacturer of compact fluorescent bulbs. MP&W reserves the right to verify installation of all qualifying equipment

**Rebate Amounts and Payments:** Rebates for compact fluorescent bulbs are 50% of the pre-tax cost. Water heaters must have an E.F. rating of .94 or greater. Room air conditioners must be ENERGY STAR rated, and central air conditioners must be rated with an S.E.E.R. of 14.0 or greater.

**Processing:** Rebate applications will be processed as they are received. Please allow 4 to 6 weeks for payment.

**Verification:** Original sales receipt indicating items purchased, date of purchase, purchase location, quantity, and price must accompany rebate application. **Incomplete applications will be returned.**
